

**APPLICATION FOR EDUCATION,
WAIVER, RELEASE, HOLD HARMLESS, INDEMNIFICATION AND
COVENANT NOT TO SUE AGREEMENT**

I hereby apply for the educational services of The Self-Rejuvenation Center, Inc. I have read the guidelines in Exhibit A and agree to abide by them.

I am fully aware that The Self-Rejuvenation Center, Inc. is not a medical facility; nor are any of its administrators, directors, agents, officers, members, volunteers, employees, other participants, sponsors, advertisers medical doctors. I also understand that The Self-Rejuvenation Center, Inc. neither diagnoses nor does it prescribe. Rather it offers education in a high level of natural living leading to rejuvenation of body, mind, and spirit. I, _____, for and in consideration of the educational benefits to be derived from my participation in sessions sponsored by the Self-Rejuvenation Center, Inc. listed on Exhibit A of this document (hereinafter referred to as “the activities or activity”) hereby waive, release, indemnify, discharge and covenant not to sue the Self-Rejuvenation Center, Inc., the Board of Self-Rejuvenation Center, Inc., the shareholder(s) of Self-Rejuvenation Center, Inc., their officers, servants, agents, or employees (hereinafter referred to as “releasees”) with regard to any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releasees or otherwise, while I am traveling to/from the activities, participating in such activities, or in, on, or upon the premises where the activities are being conducted, including my own home or office or any location selected for these activities.

I am fully aware of the risks and hazards connected with my participating in such activities, including the risk of injuries, or illnesses which can cause death, and I hereby elect voluntarily to participate in said activities, knowing that the activities may be hazardous to me. I voluntarily assume full responsibility for any risk of loss, property damage or personal injury, illness, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in the

activity (activities), whether caused by the negligence of releasees or otherwise.

I further hereby agree to indemnify and hold harmless the releasees from any loss, liability, damage or costs, including court costs and attorney's fees, that may incur due to my participation in said activities whether caused by the negligence of releasees or otherwise.

I hereby release, discharge, and covenant not to sue Self-Rejuvenation Center, Inc., their administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the activity takes place, (each considered one of the "releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement I, or anyone on my behalf, makes a claim against any of the releasees, I will indemnify, save, and hold harmless each of the releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.

It is my express intent that this Release, Hold Harmless and Indemnification And Covenant Not To Sue Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a release waiver, discharge and covenant not to sue the above-named releasees. I hereby further agree that this Waiver Release, Hold Harmless and Indemnification Agreement shall be construed in accordance with the laws of the State of Florida.

I further state, affirm and covenant that I have read in full, the entire publication of "Preserved To Serve". I agree to demonstrate evidence of having read and demonstrate that I have understood the principles delineated in Preserved to Serve via an initial telephone interview.

In signing this Waiver, Release, Hold Harmless And Indemnification And Covenant Not To Sue Agreement, I acknowledge and represent that I have read and understand the foregoing provisions; that

I sign this agreement voluntarily as my own free act and deed; no oral representations, statements, or inducement, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute voluntarily.
